

# MSP KOSHER

## KOSHER STANDARD OPERATING PROCEDURE FOR KOSHER HOT DOG STAND at TARGET FIELD

### KOSHER STATUS OF GRILLS STATION AND UTENSILS:

The grill plate/top will be under lock and key. All utensils for the station (scrapers, tongs, etc) will be labeled and painted (in part) accordingly, so that it is known that they are for the kosher cart only. They will also be kept in a special toolbox under lock and key. Designees of MSP KOSHER will have several keys and Pete Spike and his designee will have access to one key alone—for their use and their use only. Before and after a game, only these special designees can open and close the necessary equipment.

### PRODUCTS SOLD THE HOT DOG STAND:

All products served at the stand will be certified kosher, but need not be Glatt. If it is not a meat product, then it must be certified pareve. This includes all Herbivorous Butcher vegan "meats," drinks, candies/snack items and dessert products.

### CONDIMENTS:

The condiments (all kosher brands) will be kept on the cart itself, and will have a sticker on the outside of each that reads: "For Kosher Cart Only." There will also be signage that reads something akin to: "please only use these condiments for Kosher Hot Dogs from the Kosher Hot Dog Stand."

### SUPERVISION:

Designees from MSP Kosher will be granted access, upon signing in and signing out, to conduct random spot checks of the Kosher Hot Dog Stand. The grill table/equipment will be kashered by blowtorch (*libun gamur*) the morning of the subsequent non-Shabbat/Yom Tov game.
